#### **ORDINANCE NO. 987**

AN ORDINANCE OF THE CITY OF LLANO, TEXAS AMENDING THE CHARGES TO BE PAID FOR ELECTRICITY FURNISHED TO THE ULTIMATE CONSUMER OF THE ELECTRIC DISTRIBUTION SYSTEM OF THE CITY OF LLANO, TEXAS; PROVIDING FOR A REPEALER CLAUSE; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR A SEVERABILITY CLAUSE.

WHEREAS, the City Council of the City of Llano, Texas desires to amend the rates and charges to be paid for electricity furnished to the ultimate consumer of the Electric Distribution System of the City of Llano;

NOW THEREFORE, BE IT ordained by the City Council of the City of Llano, Texas, that:

**SECTION I.** The rates and charges for electricity furnished to the ultimate consumer of the Electric Distribution System of the City of Llano, Texas, shall be as set out in the following rate schedules for electric service furnished by the City of Llano Electric System, to-wit:

Electric rates are structured using a monthly Customer Service Charge, a City Distribution Charge, a variable Power Cost Adjustment and if applicable, a Demand Charge. The variable Power Cost Adjustment is the LCRA wholesale power bill to the City of Llano for wholesale power costs and services divided by the month's actual retail kilowatt hours to be billed and shall be adjusted up or down when needed by administrative action. The City of Llano will charge each customer accordingly per the following rate schedule for electricity.

# RESIDENTIAL ELECTRIC RATE

APPLICABLE: To single family residential customers for all domestic usage where all energy is taken through a single meter.

## The monthly rate shall be the sum of the following charges:

Customer Service Charge	\$5.00
City Distribution Charge <=1000 kWh City Distribution Charge > 1000 kWh	\$0.0275/kWh \$0.0425/kWh
Power Cost Adjustment	Variable/kWh

### SMALL COMMERCIAL RATE

APPLICABLE: To all non-residential customers and multiple dwelling unit residential customers billed through one meter whose peak demand does not exceed 25 kilowatts in the current billing month or any of the previous 11 billing months. Demand shall be the maximum minute measured kilowatt in the month.

## The monthly rate shall be the sum of the following charges:

Customer Service Charge \$15.00

City Distribution Charge \$0.0385/kWh

Power Cost Adjustment Variable/kWh

### LARGE COMMERCIAL RATE

APPLICABLE: To all non-residential customers whose peak demand is equal to or exceeds 25 kilowatts in the current billing month or any of the previous 11 billing months. Demand shall be the maximum minute measured kilowatt in the month.

## The monthly rate shall be the sum of the following charges:

Customer Service Charge \$50.00

City Distribution Charge \$0.0285/kWh

Demand Charge \$2.00/kW

Power Cost Adjustment Variable/kWh

**Section II.** LATE PAYMENT: Customers will be charged a late fee in the amount of ten percent (10%) of the bill if not paid on or before the 10<sup>th</sup> of the month in which the bill is rendered. If service is disconnected because of nonpayment, a \$20.00 per meter charge will be made for reconnections between 8:00am and 4:00pm on scheduled workdays. For reconnections after 4:00pm and on non-scheduled workdays, the charge will be \$30.00.

**Section III.** BE IT FURTHER ORDAINED that all parts of said Electric Ordinance of the City of Llano, Texas, not herein expressly amended above shall be and remain in full force and effect, and that all ordinances and parts of ordinances in conflict herewith be and are expressly repealed.

**Section IV.** The rates set out in this Ordinance shall be effective on February 28, 2005 billing date for each month until this Ordinance shall be amended and changed by proper action of the City Council.

**Section V.** In the event any part, provision or section of this Ordinance shall for any reason be held to be unconstitutional or void, such invalidity shall not effect the remaining portions of this Ordinance, but all parts of this Ordinance not expressly held to be void shall be deemed to be valid and binding.

### ORDINANCE NO. 1169

AN ORDINANCE OF THE CITY OF LLANO, TEXAS AMENDING SECTION I. OF ORDINANCE NO. 987 CONCERNING THE CHARGES TO BE PAID FOR ELECTRICITY FURNISHED TO THE ULTIMATE RESIDENTIAL CONSUMER OF THE ELECTRIC DISTRIBUTION SYSTEM OF THE CITY OF LLANO, TEXAS

WHEREAS, the City Council of the City of Llano, Texas desires to amend the rates and charges to be paid for electricity furnished to the ultimate residential consumer of the Electric Distribution System of the City of Llano;

NOW THEREFORE, BE IT ordained by the City Council of the City of Llano, Texas, that:

SECTION I. The rates and charges for electricity furnished to the ultimate consumer of the Electric Distribution System of the City of Llano, Texas, shall be as set out in the following rate schedules for electric service furnished by the City of Llano Electric System, to-wit:

Electric rates are calculated using a monthly Customer Service Charge, a City Distribution Charge, a variable Wholesale Cost, and if applicable, a Demand Charge. The Variable Wholesale Cost will be calculated as LCRA's monthly wholesale power bill to the City of Llano for generation, transmission, and related fees and services divided by the month's actual retail kilowatt hours to be billed. The City of Llano will charge each customer accordingly per the following rate schedule for electricity.

### RESIDENTIAL ELECTRIC RATE

APPLICABLE: To single family residential customers for all domestic usage where all energy is taken through a single meter.

The monthly rate shall be the sum of the following charges:

Customer Service Charge

City Distribution Charge <=1000 kWh

\$0.0300/kWh

\$5.00

City Distribution Charge > 1000 kWh

\$0.0450/kWh

Power Cost Adjustment

Variable/kWh
